

December 19, 2022 Bridgeton Township Board Meeting

Supervisor Barnhard calls the meeting to order at 7pm with the Pledge

Members Present: Dore, Barnhard, Holmes, Szczepaniak Absent: Thompson

Approve Agenda: Action Item D added- Discussion on Bond for Dore Property Verizon Tower, Remove Action Item C- Discussion Saved for next month. Barnhard motions to accept the agenda as revised, Dore seconds. Passes 4-0-1

Approve November Minutes: Holmes motions to approve November meeting minutes, Barnhard seconds. Passes 4-0-1

Public Comments: No comments at this time.

Consent Agenda: No minutes from the Planning Commission as they had no December Meeting.

Holmes motions to approve the reports, Barnhard seconds. Passes 4-0-1

Clerks Report: Szczepaniak read the report aloud and answered questions on the bills and amounts.

Barnhard motions to approve the bills as written and paid, Holmes seconds. Passes 4-0-1

Dore/Verizon SLU Bond Issue: Electronic copies of bond paperwork and wording in clauses are not lining up with the printed final copy. Zoning Admin spoke about the issues with clauses of the bond agreement he does not agree with and wishes to seek legal advice on changing and receiving new copies.

Sexton/Parks Manager: Requests on possible trimming of trees and branches at the launches, fence at the launch blocking the hill off may need repairs before spring opening. Will be looking at damage just reported about the fence in the cemetery.

Cemetery Workshop:

Issues with neighboring property lines and set boundaries, possible to contact the Register of Deeds at the County for full survey

Setup the boundary fence or some sort of marking system for property lines and driveways

Removal of plots near the rear of the driveway on the corners that are damaged and may be an issue for future sales.

Trimming of trees may also affect the usage of the driveway at the rear of the cemetery.

Before the spring lawncare season starts possible discussion with groundskeeper on property damage issues that have been brought up.

Drafting and changes to be made to the Cemetery Ordinance at future meetings

Proposal of the Cremains Garden was brought back up from years back as a possible new addition for the cemetery.

Budget Workshop: Date to remain as January 28th, 2023, at 10am

Junk Workshop: Discussion about setting up another Junk Workshop to continue the work and revision work done at the previous meeting.
