Guest Speaker – Scott Faulkner with The Muskegon Watershed Conservation

Update on progress of the Maple River Project, Funds from the Federal Level have been granted for road crossings and help in securing final approvals from Army Core of Engineers to begin progress and start moving ground on reopening the Maple River. Project work is continuing to guarantee that a benefit to the local area will be found in allowing the river to be reopened.

Information Items:

- A. Bryan Kolk: Commissioners Report Update to phone software is causing a surplus of 911 calls to Newaygo County dispatch. May had 4000+ calls for service from dispatch. June 6th has a record of 100 grass fires in the County.
- B. Bob Dore: Planning Commission Overview Verizon Tower is still not fully operational. River Patrol is out and currently active. August 5th is the River Clean Up Day. Tree removed, drive is graded and awaiting paving. New pay tubes are installed and ready for the launch season. Properties are still being reviewed by legal team. Discussion of mixed-use corridor.
- C. Sexton/Parks Manager Report Cemetery is up and running, grass is being planted and touched up. Lifting and releveling of headstones done. Discussion of concerns on the launches and making sure things are cleaned up before the holiday weekend.
