November 27, 2023 Monthly Meeting

- I. Routine Business
 - a. Call to Order/Pledge – Supervisor Barnhard calls the meeting to order at 7pm, starting with the Pledge
 - b. Roll Call – Board Members Present: Barnhard, Dore, Kossen-Priddy, and Holmes. Thompson - absent
 - c. Approve Agenda – Barnhard motions to approve agenda with additions of item #1 Voting Booths under clerk’s report, Dore seconds. Passes 4-0-1
 - d. Approve October 2023 Meeting Minutes – Barnhard motions to approve October Meeting Minutes with the following corrections: 1. Routine Business d. change August to September; 2. Action Item e. 1. Moved to d. 1.; 3. Information Items c. 1. Change the word give to given; 4.  - e. Public Comment: Agenda Items – public comment concerning Brooks Forbearance
- II. Action Items
 - a. Consent Agenda – Motion to approve Consent Agenda made by Barnhard, Holmes seconds. Passes 4-0-1
 - b. Clerk’s Report- Clerk Kossen-Priddy read the monthly report for the bills and payroll. Motion to approve by Barnhard, Holmes seconds. Passes 4-0-1
 - i. Voting booths – Barnhard motions to approve the purchase of two new voting booths to replace two broken booths for up to \$450.00, Dore seconds. Passes 4-0-1

 - d. Board of Public Works – Newaygo County is requesting donations to help with costs of the recycle program. Concerns were raised by the board about the township not being able to legally donate money. Barnhard will be contacting the Board of Public Works to let them know the board’s concerns with a donation and that this is not something the board is able to do.
 - e. Storage cabinets for back room - Barnhard motions to approve the purchase two storage cabinets for up to \$500.00, Holmes seconds. passes 4-0-1
