- c. Approve Agenda Barnhard adds to Information Items D. Newaygo County Road Commission Letter, Kossen-Priddy adds to Action Items D. 1. Clerk's computer. Motion to approve with additions made by Thompson, seconded by Dore. Passes 4-0-1
- d. Approve August 2023 Meeting Minutes Kossen-Priddy makes correction to Action Item B, ii, 1 for term ending November 5, 2024 to November 20, 2024. Motion to approve Meeting Minutes, with correction made, by Barnhard, seconded by Thompson. Passes 4-0-1

- a. Consent Agenda Motion to approve Consent Agenda made by Thompson, seconded by Dore. Passes 4-0-1
- b. Clerks Report- Clerk Kossen-Priddy read the monthly report for the bills presented with the note that the BHS Insurance listed on the report was voided and not paid. This bill was paid in August. Motion to approve by Thompsen, seconded by Barnhard. Approved 4-0-1.
- c. Clerk's Phone Barnhard motion to approve up to \$40 per month to reimburse clerk Kossen-Priddy for the clerk's cell phone, Thompson seconds 4-0-1
- d. Laser printer for clerk approve for up to \$300 to purchase a new laser printer for clerks use, Barnhard motions, Thompsen seconds, passes 4-0-1
- e. Clerk's Computer Barnhard motions to approve up to \$150 to have Fremont Computer update, clean up, and add anti-virus software to meet OVF requirements to the clerks computer. Thompsen seconds, passes 4-0-1
- f. Meal for election workers Barnhard motions to approve up to \$100 to provide one meal for election workers during the November 7, 2024 election, Thompsen seconds, passes 4-0-1
- g. Early voting agreement with county Barnhard motions to approve clerk Kossen-Priddy signing final early voting agreement with county for the 2024 federal elections, Thompsen seconds roll call vote Barnhard yes, Thompsen yes, Dore yes, Kossen-Priddy yes, Holmes absent, passes 4-0-1
- h. Brooks Zoning Forbearance Barnhard read email from Bryan Kolk to township attorney and response from attorney to Bryan Kolk. Barnhard motions to refer back to planning commission for further negotiations, Thompsen seconds, passes 4-0-1
- i. Boat Launches
 - i. Dock removal Thompsen motions to approve \$2,000 for dock removal, Dore seconds, passes 4-0-1

- ii. Quote for fixing washouts Dore motions to approve Hyland Property Management estimate for \$1,260.00 to repair washout at boat launch with material requested by soil erosion in Newaygo County, Thompsen seconds, passes 4-0-1
- iii. Landscaping quote -may need end pieces for guardrail, township responsible for this and permit costs. Thompsen asked about the cost of the guardrail, township has these pieces on hand already so there will be no extra costs for guardrail. Concern about equipment being run on sidewalk, Dore explained this will only be a Bobcat with auger on the sidewalk and only for short periods of time.
