Doug also asked about gun fire that was coming from the property that was being directed toward another property owners land. He also has concerns about structures that are being built on property along the river that are identified as sheds, but have decks build around them. This situation has been a concern in the past and Supervisor Barnhard said she would have Mr. Kolk look in to the situation with the property owner.
